

















## अमेरिकाद्वारा युक्तेनबारे रूसी माग अस्वीकार

काठमाडौं/एजेन्सी- अमेरिकाले युक्तेनलाई नेटो सदस्य बन्न रोक लगाउनुपर्ने रुसी मागालाई अस्वीकार गरेको छ। रूसले युक्तेनमाथि हमला गर्न सक्ने चिन्तावीच अमेरिकाको यस्तो भनाए आएको हो। अमेरिकी विदेशमन्त्री एन्टोनी बिल्ड्जनले युक्तेन सहित समाझोका लागि रूसले अधिकारेका मागको औपचारिक रूपमा जवाफ दिई अमेरिकी अडान प्रस्तुत गरेका हुन्। वार्षिकइन्फो आफ्नो मूलभूत सिद्धान्तमा कुनै छुट्टी नदिने उनले बताए। बिल्ड्जनले सहित समाझोका लागि गामीर कूटनीतिक बाटो अगाडि बढाउँ प्रस्ताव राख्दै रूसले त्यसैलाई रोजुपर्नेमा जोड दिएका छन्।
